REGULATION IDENTIFYING ZONES IN WHICH MEDICAL CANNABIS BUSINESSES MAY POTENTIALLY LOCATE

Measure Z enacted Vista Municipal Code ("VMC") Chapter 5.94 in its entirety, and further references to Measure Z will be to the provisions of that Chapter.

Authority

VMC § 5.94.090.B provides: "Medical cannabis businesses may only be located in a C-1 zone (Commercial), C-2 zone (Commercial), C-3 zone (Commercial), RLI zone (Research Light Industrial), M U Zone (Mixed Use), I-P (Industrial Park), or M-1 zone (Light Manufacturing) as designated of [sic] the Vista Municipal Code. Medical cannabis businesses are explicitly prohibited in the residential zones: R-1, R-1-B, and R-M."

Purpose

The purpose of this regulation is to identify the zoning actions which cause land to be located in in a C-1 zone (Commercial), C-2 zone (Commercial), C-3 zone (Commercial), RLI zone (Research Light Industrial), M U zone (Mixed Use), I-P (Industrial Park), or M-1 zone (Light Manufacturing) for purposes of VMC § 5.94.090.B (each zone being designated an "MCB-Eligible Zone").

Rule

For purposes of VMC § 5.94.090.B, land is located within an MCB-Eligible Zone in one of two ways:

- 1. Pursuant to the current zoning map adopted as provided in VMC § 18.06.020; or
- 2. Pursuant to a current SP Zone, adopted under VMC Chapter 18.20, if the land on which the medical cannabis business will locate is within an area, unit, or district created by a specific plan ("Area"), and the specific plan either:
 - expressly provides that the Area will be zoned as C-1 zone (Commercial), C-2 zone (Commercial), C-3 zone (Commercial), RLI zone (Research Light Industrial), M U zone (Mixed Use), I-P (Industrial Park), or M-1 zone (Light Manufacturing); or
 - expressly provides that the uses permitted in the Area are those permitted in one of the following zones: C-1 zone (Commercial), C-2 zone (Commercial), C-3 zone (Commercial), RLI zone (Research Light Industrial), M U zone (Mixed Use), I-P (Industrial Park), or M-1 zone (Light Manufacturing).

Application of Rule

Land is located within a MCB-Eligible Zone for purposes of VMC § 5.94.090.B, if the land is within an Area identified in the following table:

Note: Portions or the entirety of certain Areas in Column Two above may be or may become ineligible for medical cannabis businesses based on separation requirements imposed by State Law and/or VMC § 5.94.090.

Except as listed above, no Specific Plan nor any Area in a Specific Plan, is available for medical cannabis businesses under VMC Chapter 5.94.
