As part of the pilot program the County will provide 222 seniors who are at-risk of homelessness with a flat rental subsidy of \$500 a month for 18 months, payable directly to their landlord. Assistance payments are anticipated to begin in Spring 2023.

Who is Eligible:

The program is designed to serve older adults who are


- Residents, age 55+, and at risk of homelessness.
- Applicant must have a household income at or below 50% of the Area Median Income. To view the Income Limits AMI Chart, visit www.sandiegocounty.gov
- Applicant's household must be severely rent-burdened and paying more than 50% of their income toward housing costs.
- Applicant must have a lease or rental agreement in their name, and a landlord willing to participate in the program.
- Applicant must not be receiving funds from another rental subsidy program.
- All participants must sign consent forms to participate in the program and an evaluation.

***Pilot program participants who meet the eligibility criteria will be selected at random. All participants are required to submit an application, even if they previously joined an interest list. Funding is limited and with the current funding the program can assist 222 households.
