II. Discussion

- Immediate Encampment Removal Form
 - i. Keep record of preference to store or dispose of items
 - ii. For use in immediate encampment removals (i.e. items in right of way)
 - iii. Legal vs social enforcement of individuals who have multiple contacts/citations
- Citing campers
 - i. Ability to cite outside of ROW
 - ii. Multiple encounters
- Other outreach providers
 - i. County social workers, PATH
- Permanent Notice of Cleanup postings
 - i. Would supersede need for 72 hour notices
 - ii. Follow through/consistency is important, will also need to post if not cleaning up
 - iii. Start small, with something feasible and expand as we're able (ex. would need CalTrans cooperation for overpasses)
 - iv. What range would the signs cover? How close together should they be posted?
 - v. Can private properties/caltrans/etc recreate similar signs
 - vi. Change ambiguous wording- "items that appear to be of value"
- Regular outreach schedules

- i. Bi-weekly code enforcement/pw walkthrough with deputy
 - Less frequent during cold, rainy season
- ii. Exodus Tuesday and Friday mornings
- iii. Coordinated through email, usually sent out a week in advance
- iv. Drone walkthrough? Safer and less intrusive
