II. Discussion

- BCNC Overnight Intakes
 - o Overnight intakes not currently offered anywhere is San Diego County
 - Has shown to be expensive, not a high need
 - o Leaving a bed open would not be equitable to individuals on waitlist
 - o Additional staff for overnight needs would mean additional costs for staffing
 - o Would Motel Vouchers be a backup option?
 - Increase in liability for hotel, individual, and associated costs
 - Sheriff or referring party may be able to make this judgement call
 - Motel Voucher program not available yet
 - Palette Shelter as another backup option?
 - Would not disrupt clients and other operations overnight
- Trespass Authorization Letter and Signage
 - o This would be a standing authorization from property owners to allow Sheriff's to enforce trespassing on private property
 - Letters on file could last for up to one year
 - Would make it easier for Sheriff's department to access/assist
 - Signage is a legal requirement, acts as a deterrent, and allows for greater enforceability
 - Sign must be easily visible

- City is looking into grants to cover cost of signage
 - Will need council approval to waive associated fees
- o Plan is to implement signage downtown before considering city-wide
 - 306 active Business Improvement District business licenses
- Alliance for Regional Solutions Shelter Network Contract Update
 - o Historically, this contract has been \$200,000 per year, or \$50,000 per guarter
 - o Program years from October through September
 - o Recently amended to pay per shelter bed night, up to ceiling price of \$200,000
 - This amount had been fully expended during January 2024
 - ARS will continue services for contract year and come back with data to support future funding strategies
- Glossary of Terms
 - o A glossary of terms has been created to allow for more consistent use of terms during discussions of homeless services in Vista

- City Attorney's Office
 - o Discussion regarding San Diego's Encampment Ban
 - o No changes or updates to Martin v. Boise, but may be considered by appellate court
- Community Improvement Team
 - o 17 encampments cleaned in January, 14 encampments cleaned in February, 14 encampments cleaned in March
 - Amount cleaned from encampments lessens each month
 - o Discussion regarding encampment abatement
 - Not enforceable unless property is labeled a "public nuisance"
- Recreation & Community Services
 - o Increase in overnight activity, especially in Breeze Hill, Wildwood, Shadowridge, Thibido, & Brengle Terrace
- Public Works
 - o Noted instance where upon arriving at skate park to clean graffiti, individual was sleeping in bathroom and declined to leave
 - Deputy Pedersen informed staff should continue to call Sheriff's non-emergency line for assistance
- Planning
 - o Council Update in May regarding old Burlington Coat Factory

IV. Overview of Strategic Plan Activities in Progress

- City of Escondido Policy Statement
 - o Public safety is in conflict with Housing First
 - o Direction from Standing Committee on Homelessness to agendize for City Council meeting
- BCNC up to 38 clients
 - Nearing capacity and staff will begin focusing on case management once full
