## SUBMITTAL STANDARDS

- All exhibits shall be in a pdf format, with a graphic scale, and rotated so that the pages read upright.
- exhibits shall be combined into one complete set, no individual sheet submittals
- save files in black and white
- files must be unlocked and unprotected.
- zip files are not accepted.
- Legal Description and plat maps for a single parcel may be combined, multiple parcels, maps and other documents must be submitted as a separate pdf file for each document (e.g. deeds, maps, existing easements, title reports, traverse closures, reports, etc.)

## PROVIDE COMPLETE DIGITAL SUBMITTAL of the following through file sharing link or USB drive, plus HARD COPIES as noted.

## □ This Submittal Checklist

- (Digital + 1 copy) **Transmittal Letter** from Engineer of Work listing all items been submitted
- (Digital + 2 copy) Legal Description of easement, dedication or covenant. Legal description shall be on an 8 ½" X 11" sheet, typewritten, and labeled "Exhibit A." For Covenants, Exhibit A is the legal description for the burdened property and Exhibit B is the legal description for the benefitting property.
- □ (Digital + 2 copy) Plat, each on a separate 8 ½" X 11" sheet labeled "Exhibit B." For Covenants, the plat will be label Exhibit C. Each Plat should:
  - Be prepared, signed, and stamped by a Professional Land Surveyor (PLS) or Registered Civil Engineer (RCE) with registration number of 33965 or lower.
  - Provide a vicinity map indicating the location of the project if not identifiable by existing street intersection on Plat.
  - North Arrow, scale, page number(s)
  - Clear dimensions along entire easement, dedication or covenant.
  - Provide vesting of granting property
- □ (Digital + 1 copy) Current **Title Report** less than 3 months old in **pdf with working hyperlinks**.
- □ (Digital + 1 copy) Vesting Deed
- □ (Digital Only) Map Check Traverse calculations, with bearings shown in xxx□xx'xx" format and distances shown with two significate digits (xxx.xx') with signature and seal.
- □ (Digital Only) Copy of all map references, records of survey, deed used to prepare the legal description and easement documents listed in the title report
- □ (Digital Only) Copy of documentation providing authority to sign easement, dedication or covenant, if legal entity is other than an individual (e.g., legal entity is a corporation)
- □ Fees Plan check fees due upon the acceptance of 1<sup>st</sup> submittal. Please contact city staffs for initial fee invoice and acceptable payment methods before initial submittal. Please visit <u>city website</u> for fee schedule as needed.
