In consideration for the City of Vista granting participant permission to participate in the program listed above, the undersigned agrees to: (1) **FOREVER RELEASE, DISCHARGE, AND WAIVE ANY AND ALL LIABILITY CLAIMS OR DEMANDS ARISING OUT OF PARTICIPATION IN THE PROGRAM LISTED ABOVE AGAINST THE CITY OF VISTA**, its employees, agents, independent contractors, and/or volunteers (“Releasees”) that the **UNDERSIGNED, HIS OR HER PERSONAL REPRESENTATIVE(S), SUCCESSOR(S) IN INTEREST, ASSIGN(S), HEIR(S), OR DEPENDENT(S)** has or might have against Releasees, now or in the future, and whether or not said claims and/or demands are or were caused by acts of the

Releasees and/or any other person or entity, and, (2) expressly waive and relinquish all rights and benefits afforded by CA Civil Code section 1542 which provides as follows: “A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party.” \_\_\_\_\_(Initial)

**INDEMNITY**

In consideration for the City of Vista allowing participant to participate in the above listed program, the **UNDERSIGNED, HIS OR HER PERSONAL REPRESENTATIVE(S), SUCCESSOR(S) IN INTEREST, ASSIGN(S), HEIR(S), or DEPENDANT(S) AGREE TO INDEMNIFY, HOLD HARMLESS AND DEFEND** Releasees from any legal obligation, claim and/or liability, whether or not caused by the acts of Releasees or any other person or entity, arising out of participation in the above listed program. By signing **THIS EXPRESS ASSUMPTION OF THE RISK, RELEASE, WAIVER, AND INDEMNITY AGREEMENT** (“Agreement”), the undersigned acknowledge(s) that: (1) my participation in the above listed recreational sport or activity is voluntary and I am aware of the potential dangers incidental to engaging in said recreational sport or activity, including the possibility of contracting COVID-19; (2) I have fully read and understood the Agreement; and (3) knowing the risks involved, I acknowledge and agree the Agreement is a contract that **EXTINGUISHES CERTAIN LEGAL RIGHTS AND IMPOSES OTHER LEGAL OBLIGATIONS** and wish to extinguish and/or waive said legal rights and obligations. I also acknowledge and understand that my failure to initial where indicated above does not invalidate the Agreement or any provision of the Agreement. Lastly, if the Participant is a minor, his or her custodial parent or legal guardian acknowledges that they have read and understood the terms of this Agreement and by signing agrees to be bound by all the terms in the Agreement and agrees to bind the minor to all the terms of the Agreement.
