II. Discussion

- Glossary of Terms
 - Updated definition of encampment no longer relies on "structures", has been amended to include "totality of circumstances" and discretion of authorizing agency.
- ERF-3
 - ERF-1 contract with Exodus expired April 26, 2024, PLHA contract remains in place until September 2024
 - New RFP will be needed for new grant award
 - Will be released soon
 - New grant focus shifting away from clearing encampments, and more towards providing services
 - Extend safe parking, continue outreach, master leasing, grant-funded positions, etc.
 - Does not provide funding for fencing, signage, or community improvement projects
 - Grant area to include 78 corridor and surrounding, high-transit areas including downtown
 Vista Village and University/Sycamore
 - \$3-4 mil. application, hoping to receive notice of award in September.
- County intent to purchase Green Oak Ranch for mental health services
 - Land trust dictates it be used for rehabilitation services
 - Resident concerns over Vista's capacity to provide mental health services on top of BCNC and County Jail
 - Dan O'Donnell Town Hall Meeting June 30, 2024- Morris B Vance Community Room 12-3pm

III. Overview of Strategic Plan Activities in Progress

- City Council Update on the Implementation of the Strategic Plan to Address Homelessness
 - June 6, 2024 at 5:30pm, Council Chambers
- Park Ranger enforcement of encampments
 - Attorney's office to look into abilities to enforce/address policies
 - Overnight car camping not a concern in parks with overnight gates
 - Noted overnight car camping has not been a concern in downtown Vista Village either
- Motel Vouchers
 - CDBG-CV funds
 - Use for quarantine entry/bridge housing/emergency accommodations/etc
 - Not for long term stay
 - Still determining referral process, motel agreements, and other programmatic needs
- Home Share & Townspeople
 - RTFH Grant for master leasing and housing navigation
 - Properties provide favorable rates to government agencies
 - Discussion over concern of City evicting subleased residents
